# **Public Works:**

- 1) Main Street due to condition of the road, the cost would increase by approx. \$13,000. (Total cost for crack fill, fog & amp; chip seal would be near \$84,000) Considering that the village has applied for a grant for 2024 the recommendation from the road commission is to crack fill & surface patch this year at a cost of approx.\$14,000. (Chaney/Ludwig) Motion to have N. & S. Main St. crack filled and surface patched by RCKC at a cost of \$13,877. CARRIED -Roll Call 5-0
- 2) Concern regarding a tree at 115 S. Main St. 2 quotes WT Forestry \$4500, Romans \$5500. (Sutherland/Ludwig) Motion to accept the bid from WT Forestry to remove the tree at 115 S. Main St. at a cost of \$4500.
- 3) Have changed a 25 water meters for residents. Still have plenty of new meters on hand.
- 4) Results of recent water samples are all good.
- 5) TJ & Samp; Forrest will be attending a webinar on Water System Finances on Thursday.
- 6) Cemetery is busy funeral tomorrow, two next week, several headstones getting placed.
- 7) Would like to replace more sidewalks this year since we are not paving Main St.

- 2) Working on another grant to have the railroad tracks on Main St. repaired.
- 3) Continuing to work on the quiet zone/no horn area for the train coming through the village.
